

2025-26 WATER YEAR SNOWY RIVER DAILY RELEASE TARGETS

Updated - 9 Apr 25

Daily release patterns are notified to Snowy Hydro Ltd from the NSW DCCEEW in February of the preceding water year.

Note: Daily targets and high flow volumes may be updated by NSW DCCEEW at any time. All updates will be uploaded to the Snowy Hydro website as they occur.

Days highlighted in yellow include an 8 hour high flow event. This means that for 8 hours on these days, flows from the dam will be significantly higher than the daily target. The peak values for the days highlighted in yellow are shown on the right.

* Note for #4: If the reservoir level allows, NSW DCCEEW has requested an 8hr peak release of 9000 ML/d. The reservoir level will be assessed prior to the event and if it is not possible, then a release of 5000 ML/d will be made over a 24 hour period. Final volumes will be determined closer to the date and this document will be updated if required.
